Henniger and seconded by McOllough to approve First Reading of Ordinance 615. Motion failed 2-3 (D. Hennigar, Flurer & Young)

Motioned by Flurer seconded by S.Hennigar to approve Resolution (22-109) approving pay request #3 with McKeniss Excavation for WFL Phase 2 (Aspen Dr) for \$147,810.25. All Ayes. Motion passed.

Motioned by D. Hennigar seconded by McOllough to approve Resolution (22-110) Setting Public Hearing on Community Development and Housing Needs Assessment. All Ayes. Motion passed.

Motioned by Flurer seconded by S.Hennigar to approve Resolution (22-111) Setting Public Hearing on Submission of A CDBG Application. All Ayes. Motion passed.

Flurer commented on the graffiti at the pool park was cleanly removed. Thanked the city workers for doing a good job.

Fire Dept representative commented on the safety classes the Clarion FD assisted with in other communities.

Motioned by Young seconded by McOllough to adjourn. All Ayes. Meeting adjourned.
