Motioned by Flurer seconded by Young to approve Resolution (22-139) approving pay request #4 (Final) with Hennigar Construction for Daycare for \$4,645.06. All Ayes. (D. Hennigar-Conflict, S. Hennigar-Absent: Motion passed 3-1).

Motioned by Young seconded by D. Hennigar to approve the hiring of Hector Nino as Police Officer effective December 19th. All Ayes. (Motion passed 4-0).

Comments to the Council: Jon has found a compromise with MidAmerica to replace the lights at Casey's intersection. That work has been ordered through MidAmerica.
