INTERNATIONAL MUNICIPAL COOPERATION AGREEMENT

ARTICLE I

LEGAL BASIS

1. The municipalities have agreed to reach this cooperation agreement as follows

a. Junik. Referring to the Law on Local Self-Government No. 03 / L-040 article 17 and 30, Law on Inter-Municipal Cooperation, No.04 / L-010, Article 18 and Regulation on Municipal International Cooperation 0203/1334; Based on the decision of the Municipality of Junik, date; 31 March 2022.

b. Clarion. As authorized by Section 364.1 of the Code of Iowa, and Sections 1.03 and 17.02(1) of the Code of Ordinances, and adopted by Resolution 22-49 on May 17, 2022.

ARTICLE II

PURPOSE

1. The purpose of this Agreement is: Municipal International Cooperation between the Municipality of Junik in the Republic of Kosova and the Municipality of Clarion, in the State of IOWA;

2. Cooperation shall be implemented on the basis of equal reciprocity and mutual benefit.

ARTICLE III

SUBJECT OF THE AGREEMENT

1. Municipal International Cooperation between the Municipality of Junik in the Republic of Kosova and the Municipality of Clarion in the state of IOWA.

ARTICLE IV

FIELDS OF COOPERATION

1. In order to develop and promote Municipal International cooperation, municipalities will cooperate in the fields of:

- a. Implementation of joint cultural and recreational projects;
- b. Exchange of experiences of school institutions and cultural-artistic associations;
- c. Exchange of experiences in the field of art, culture and other educational activities;
- d. Exchange of experiences in the field of Sports;

e. Exchange of experiences in the field of Agriculture.

ARTICLE X

THE RIGHTS AND OBLIGATIONS OF THE PARTIES INVOLVED IN THE AGREEMENT

1. The signatory parties to the Memorandum of Understanding respect the free will of the Municipalities in the field of International Municipal Cooperation.

ARTICLE XI

OTHER OBLIGATIONS

1. The Parties shall take the necessary measures to carry out the activities at all stages of the implementation of this Agreement and the signing of other subsequent acts arising from this mutual cooperation relating to International Municipal Cooperation.

ARTICLE XII

COORDINATION BETWEEN THE PARTIES

1. The parties to this agreement agree on a representation of the respective municipalities for the implementation of joint activities set out in this cooperation agreement.;

ARTICLE XIII

FINAL PROVISIONS


- 1. This contract will take effect on the date of its signing and may last until June 1, 2032;
