Motion Young, seconded Maxheimer to approve resolution 19-62 to fix a date for a public hearing on December 3rd, 2019 at 4:30pm to enter a Water Revenue Loan and Disbursement Agreement and to borrow money thereunder in a principal amount not to exceed \$1,500,000. Roll call: Young, Aye; Hennigar, Aye; Maxheimer, Aye. Motion passed.

Motion by Hennigar, seconded by Maxheimer to approve purchase of a video storage computer for the police department. All ayes, motion passed.

Motion by Young, seconded by Maxheimer, to adjourn. Mayor Asbe declared the meeting adjourned at 5:38pm.
