Director Littlejohn and Mayor Heiden discussed the concerns arising with being asked to cover Eagle Grove EMS on a
higher frequency than the agreement was intended. They will be working with the county representative to coordinate a
plan moving forward.

Middleton added to his report that the water treatment facility has increased in its projected cost to an amount that is concerning. They have also been looking into any new news as to how the Bipartisan Infrastructure Law (BIL) will impact projects in Iowa. So much is unknown on the BIL and we need to get moving on this to take advantage of CDBG moneys we have been granted and the low interest loan we have received from USDA. More research will be done in coming days.
